



BAC RESOLUTION DECLARING AVP CATERING SERVICES AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) FOR THE CONTRACT: PROVISION OF CATERING SERVICES DURING THE BUGASS YEAR-END ASSESSMENT AND PLANNING FOR 2025 ON DECEMBER 18, 2024
Resolution No. SCRQ-643-24-AMP

WHEREAS, the BICOL UNIVERSITY requested for the project **Provision of Catering Services during the BUGASS Year-End Assessment and Planning for 2025 on December 18, 2024** with an Approved Budget for the Contract (ABC) of **One Hundred Sixty-Five Thousand and 00/100 Pesos (Php165,000.00)**;

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website & BAC Bulletin Board for the period December 3 to 9, 2024;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, five (5) suppliers were provided with quotation forms namely, AVP Catering Services, Lala's Foodhaus & Catering Services, Bicol Food Delights Catering Services, Ballarbare Catering Services & Jcharex, and four (4) bidders submitted the quotation with results as follows;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



- To recommend for approval by VP for Administration & Finance the foregoing findings.


