



BAC RESOLUTION RECOMMENDING CONTRACT AWARD TO JOINT VENTURE OF CENTURION DIGITAL INFRASTRUCTURE AND DEVELOPMENT CORP. AND REMAX INTERNATIONAL INC. FOR THE ICT MODERNIZATION FOR INTELLIGENT CAMPUS DEVELOPMENT PROGRAM

WHEREAS, the BICOL UNIVERSITY-UBAC received the project documents (Job Order and TOR) dated December 23, 2024 from the Information & Communication Technology Office relative to the **ICT Modernization for Intelligent Campus Development Program** with an Approved Budget for the Contract (ABC) in the amount of **One Billion Five Hundred Million Pesos (Php1,500,000,000.00)**, inclusive of taxes; under the 2024 General Appropriation Act / Capital Outlay Fund 01;

WHEREAS, on the basis of the said project, after the conduct of the Pre-Procurement Conference on January 9, 2025, and the finalization of the bidding documents, the Members of the Bids and Awards Committee caused the posting of the Invitation to Bid on January 15, 2025 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Bicol University website, BU-PrMO Facebook Page and the bulletin boards within the Bicol University premises;

WHEREAS, eight (8) prospective bidders and their representatives attended the Pre-Bid Conference on January 23, 2025, namely:

WHEREAS, with an ABC in the amount of One Billion Five Hundred Million Pesos (Php1,500,000,000.00), inclusive of taxes, and after passing the detailed technical evaluation conducted by the Members of the Bids and Awards Committee, the bid of Joint Venture of Centurion Digital Infrastructure and Development Corp. and Remax International Inc. in the amount of One Billion Four Hundred Ninety-Eight Million One Hundred Pesos (Php1,498,000,100.00) was declared as the *Single Calculated Bid*, subject to post-qualification process;

WHEREAS, the notice for submission of post-qualification documents was issued to Joint Venture of Centurion Digital Infrastructure and Development Corp. and Remax International Inc. on February 7, 2025, which upon its receipt submitted the documents within the notification period;


WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsive of the bid based on the documents submitted, post-qualification was conducted by the Members of the Bids and Awards Committee on the basis of its documentary submissions. The Post-Qualification Report on Joint Venture of Centurion Digital Infrastructure and Development Corp. and Remax International Inc. dated February 11 & 12, 2025 was submitted to the Members of the Bids and Awards Committee for its consideration;

WHEREAS, after review and evaluation of the findings of the post-qualification team on Joint Venture of Centurion Digital Infrastructure and Development Corp. and Remax International Inc. documentary submissions, the Members of the Bids and Awards Committee is of the view that Joint Venture of Centurion Digital Infrastructure and Development Corp. and Remax International Inc. has met the requirements of the Bicol University and declared its bid as the *Single Calculated and Responsive Bid*;


NOW THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- a.) **RECOMMENDED** the **AWARD** of the contract for the **ICT Modernization for Intelligent Campus Development Program** to **JOINT VENTURE OF CENTURION DIGITAL INFRASTRUCTURE AND DEVELOPMENT CORP. AND REMAX INTERNATIONAL INC.**, in the contract amount equivalent to **ONE BILLION FOUR HUNDRED NINETY-EIGHT MILLION ONE HUNDRED PESOS (Php1,498,000,100.00), inclusive of taxes;** and
- b.) To recommend for approval by the President of BICOL UNIVERSITY the foregoing findings.
