# D. RESPONSIBILITIES OF THE CERTIFYING BODY

The Certifying Body shall have the following responsibilities:

- a. Provide BU its company profile highlighting related projects, scope of work and implementation methodology. Curriculum vitae of the proposed certification team shall also be submitted.
- Abide with the auditing principles, terminologies and guidelines as specified in the ISO 19011:2011 – Guidelines for Quality Management Systems Auditing.

- c. In order to avoid conflict of interest, Certifying Bodies that have provided quality management system consulting services or site-specific auditor training to a particular group/unit within the agency, shall not be contracted as a Certifying Body for BU.
- d. Include in the proposal the audit activities and a procedure for client appeals. Any dispute which may arise between BU and the Certifying Body shall be resolved amicably in good faith. However, BU shall be afforded the right to lodge appeals about the decisions of the audit team through the accreditation body. Further, the parties are not precluded from resorting to any legal remedy that may be available to them.
- e. Adhere to the agreed scope of work/deliverables which were approved by BU.
- f. Provide a full report on the operations audited consistent with the content of the approved scope of work/deliverables to the agency within ten (10) days of each initial, surveillance and re-surveillance audits unless otherwise agreed by BU.
- g. All information reviewed and recorded by the Certifying Body audit team would be treated in the strictest confidence at all times.

## II. Financial Proposal

- a. The Approved Budget for the Contract (ABC) shall be the upper limit or ceiling for acceptable Financial Proposal. Financial Proposal received in excess of the ABC shall be automatically rejected.
- b. The Financial Proposal shall be computed as follows:
  - b.1 The lowest Financial Proposal shall receive the maximum score of 40%.
  - b.2 The scores of other Financial Proposals shall be computed using the formula:

Financial Score = Lowest Financial Proposal/Financial Proposal of the Proponent x 0.40

#### III. Overall Rating

The overall rating of the proponent shall be the sum of the ratings earned for the Technical Proposal and Financial Proposal. The contract shall be awarded to the Highest Rated Bid.

#### H. PAYMENT TERMS

Payment shall be made in three (3) installments upon completion of each of the following milestones and submission of the required deliverables, to wit:

#### **BICOL UNIVERSITY AGENCY PROFILE**

## **Background**

Bicol University was founded on June 21, 1969 by virtue of Republic Act 5521 and was formally organized on September 22, 1970. It evolved out of six reputable educational institutions integrated to form the first state university in Region V:

- Bicol Teachers College (BTC)with its Laboratory School in Daraga, Albay, now the BU College of Education (BUCE) with its Integrated Laboratory School (ILS)
- Daraga East Central School (DECS)also in Daraga, Albay, initially renamed as Bicol University Pilot Elementary School (BUPES), now integrated with the BUCE-ILS as its Elementary Department
- Albay High School in Legazpi City, now the BUCE-ILS High School Department
- Bicol Regional School for Arts and Trades (BRSAT)in Legazpi City, converted from the Albay Trade School by virtue of Republic Act 1129 on June 16, 1954, now the College of Industrial Technology and the College of Engineering.
- Roxas Memorial Agricultural School (RMAS)in Guinobatan, Albay, which became the College of Agriculture, now renamed as the College of Agriculture and Forestry.
- School of Fisheries in Tabaco, Albay, turned into the College of Fisheries, now the Bicol University Tabaco Campus.

These public schools and colleges, now part of Bicol University, had served the people of the region for more than half a century prior to their forming Bicol University.

From the early seventies and onwards, the College of Arts and Sciences (BUCAS), Nursing (BUCN), the Institute of Computer Science (BUCSI), Local Government (BUILG), Physical Education, Sports and Recreation (BUIPESR), and Peace and Security Studies (BUIPSS) came one after another, as degree granting colleges and institutes, along with the Regional Science Teaching Center (RSTC). At the apex of the academic colleges and institutes is the Graduate School (BUGS) that offers advanced degrees at the master's and doctorate levels in various disciplines and fields of studies. To bring the academic programs of Bicol University nearer its clientele, its curricular programs were extended to Gubat, Sorsogon and Camp Crame, Quezon City.

The full implementation of the vertical articulation of the course programs in accord with the university's academic plan contained in the Bicol University Comprehensive Development Plan: 2003-2013 was effected in SY 2004-2005.

The school year 2004-2005 saw the emergence of the College of Science (CS), College of Arts and Letters (CAL), College of Social Science and Philosophy (CSSP) and the College of Business, Economics and Management (CBEM) mainly as service colleges for general education courses and professional colleges, too. Simultaneously, the same school year saw the full implementation of the decentralization of the graduate programs and the integration of institutes and centers to relevant colleges.
