WHEREAS, the BICOL UNIVERSITY requested for the project Provision for the rental of Acrylic Stage, Sound System, lights and Generator Set for the conduct of the 55th Commencement Exercises for CY 2025 of Bicol University on June 24 and 25, 2025 at Bicol University with an Approved Budget for the Contract (ABC) of One Hundred Seventy Thousand and 00/100 Pesos (Php990,000.00):

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website and BAC Bulletin Board for the period May 29 to June 2, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications:

WHEREAS, five (5) suppliers were provided with quotation forms namely, VRM EVENTS, ARAL LAMPARA AT MUSIKA SOUND SYSTEM SERVICES, OROG PRO LIGTHS & SOUND, CS CREATIVITY AND SIMPLICITY PHOTOGRAPHY, ELITE CASIGURAN LIGHT & SOUND and four (4) bidders submitted the quotation with results as follows:
