



**BAC RESOLUTION DECLARING A4R ENTERPRISES AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE BID (SCRQ) FOR THE CONTRACT: PURCHASE OF ELECTRICAL SUPPLIES TO BE USED IN THE UNIVERSITY LIBRARY SYSTEM AND OFFICES**

WHEREAS, the BICOL UNIVERSITY requested for the project **Purchase of Electrical Supplies to be used in the University Library System and Offices** with an Approved Budget for the Contract (ABC) of **Seventy Eight Thousand and 00/100 Pesos(Ph78,000.00)**;

WHEREAS, the BAC resorted to Shopping (Section 52.1b) as an alternative mode and posted the project in the GEPS website, Agency website & BAC Bulletin Board for the period June 3 to 9, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, five (5) suppliers were provided with quotation forms namely, A4R ENTERPRISES, HAPPY ELECTRICAL STORE, JM OLBES MKTG, NEW DARAGA DY ENT., UNICO TRADING, and five (5) bidders submitted the quotation with results as follows;


