



BAC RESOLUTION DECLARING MARYED MUSICSPTS ZONE AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE BID (SCRQ) FOR THE CONTRACT: PROVISION OF LABOR AND MATERIALS OF COSTUME TO BE USED BY UNIVERSITY DANCE TROUPE

WHEREAS, the BICOL UNIVERSITY requested for the project **Provision of Labor and Materials of Costume to be used by University Dance Troupe** with an Approved Budget for the Contract (ABC) of **Three Hundred Thirty Thousand and 00/100 Pesos (Php330,000.00)**;

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website and BAC Bulletin Board for the period May 8 to 14, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, three (3) suppliers were provided with quotation forms namely, GPLUS ENTERPRISES, ACTIVEWEAR, MARYED MUSICSPTS ZONE and two (2) bidders submitted the quotation with results as follows;
