## BAC RESOLUTION DECLARING NUPRINT MASTER AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE BID (SCRQ) FOR THE CONTRACT: PROVISION OF LABOR AND MATERIALS FOR THE PRINTING AND DELIVERY OF DIPLOMA FORMS, TRANSCRIPT FORMS AND CERTIFICATION FORMS IN THE UNIVERSITY REGISTRAR'S OFFICE

WHEREAS, the BICOL UNIVERSITY requested for the project Provision of Labor and Materials for the Printing and Delivery of Diploma Forms, Transcript Forms and Certification Forms in the University Registrar's Office with an Approved Budget for the Contract (ABC) of Six Hundred Thousand and 00/100 Pesos (Php600,000.00);

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website and BAC Bulletin Board for the period June 13 to 17, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of

WHEREAS, three (3) suppliers were provided with quotation forms namely, PALANCA PRINTING PRESS, NUPRINT MASTER, BENGX PRINT GRAPHIC ARCHITECTURAL SERVICE and two (2) bidders submitted the quotation with results as follows;
