



BAC RESOLUTION DECLARING BICOL FOOD DELIGHTS AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE BID (SCRQ) FOR THE CONTRACT: PROVISION OF CATERING SERVICES FOR THE 56TH CHARTER DAY OF BICOL UNIVERSITY 2025

WHEREAS, the BICOL UNIVERSITY requested for the project **Provision of Catering Services for the 56th Charter Day of Bicol University 2025** with an Approved Budget for the Contract (ABC) of **Three Hundred Ninety-One Thousand Two Hundred Fifty and 00/100 Pesos (Php391,250.00);**

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website and BAC Bulletin Board for the period June 11 to 16, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, three (3) suppliers were provided with quotation forms namely, BICOL FOOD DELIGHTS, A.V.P. CATERING SERVICES, A AND A BED AND BREAKFAST INN CORP. and one (1) bidder submitted the quotation with results as follows;


