



**BAC RESOLUTION DECLARING BICOL FOOD DELIGHTS CATERING SERVICES AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) FOR THE CONTRACT: PROVISION OF FOOD/ CATERING SERVICES FOR UNIVERSITY-WIDE GENDER AND DEVELOPMENT (GAD) YEAR-END ASSESSMENT, ACCOMPLISHMENT REPORT AND PLANNING WORKSHOP (YAARPW) AND GAD PLANNING AND BUDGET AT BUCGAD CONFERENCE ROOM, BSBI BLDG., BICOL UNIVERSITY MAIN CAMPUS ON DECEMBER 17-19, 2025**

WHEREAS, the BICOL UNIVERSITY requested for the project **Provision of Food/ Catering Services for University-Wide Gender and Development (GAD) Year-end Assessment, Accomplishment Report and Planning Workshop (YAARPW) and GAD Planning and Budget at BUCGAD Conference Room, BSBI Bldg., Bicol University Main Campus on December 17-19, 2025** with an Approved Budget for the Contract (ABC) of **One Hundred Eight Thousand and 00/100 Pesos (Php108,000.00);**

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website and BAC Bulletin Board for the period December 7 to 10, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, three (3) suppliers were provided with quotation forms namely, **BALLARBARE CATERING SERVICES (QUEEN SISTERS CORP.)**, **BICOL FOOD DELIGHTS CATERING SERVICES**, **A.V.P. CATERING SERVICES**, and three (3) bidders submitted the quotation with results as follows;


