



BAC RESOLUTION DECLARING BENGX PRINT GRAPHIC & ARCHITECTURAL SERVICE AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) FOR THE CONTRACT: PROVISION OF LABOR AND MATERIALS FOR TOKENS FOR LEARNING SERVICE PROVIDERS (LSPS), PARTICIPANTS AND GUEST IN VARIOUS HRMDO ACTIVITIES

WHEREAS, the BICOL UNIVERSITY requested for the project **Provision of Labor and Materials for Tokens for Learning Service Providers (LSPs), Participants and Guest in Various HRMDO Activities** with an Approved Budget for the Contract (ABC) of **One Hundred Thousand and 00/100 Pesos (Php100,000.00)**;

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website and BAC Bulletin Board for the period November 27 to December 1, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, four (4) suppliers were provided with quotation forms namely, **AC ENTERPRISES**, **COTTON CITY MARKETING CORP.**, **BIDWELL ENTERPRISES**, **BENGX PRINT GRAPHIC & ARCHITECTURAL SERVICE**, and three (3) bidders submitted the quotation with results as follows;
