



**BAC RESOLUTION DECLARING AC ENTERPRISES AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) FOR THE CONTRACT: PROVISION OF TOKENS DURING THE OPENING MEETING ON JANUARY 2026**

WHEREAS, the BICOL UNIVERSITY requested for the project **Provision of Tokens during the Opening Meeting on January 2026** with an Approved Budget for the Contract (ABC) of **Ninety-Two Thousand and 00/100 Pesos (Php92,000.00)**;

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, Agency website and BAC Bulletin Board for the period December 16 to 22, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, four (4) suppliers were provided with quotation forms namely, **AC ENTERPRISES, NUPRINT MASTER, BRUSHWORKS ADVERTISING, J & E PRINTING PRESS**, and two (2) bidders submitted the quotation with results as follows;




