



BAC RESOLUTION DECLARING ELJOE'S CATERING SERVICES AS THE BIDDER WITH THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) FOR THE CONTRACT: PROVISION OF CATERING SERVICES FOR THE MONTHLY MEETINGS OF THE PRESIDENT (FEBRUARY-DECEMBER 2026)

WHEREAS, the BICOL UNIVERSITY requested for the project *Provision of Catering Services for the Monthly Meetings of the President (February-December 2026)* with an Approved Budget for the Contract (ABC) of *Three Hundred Thousand and 00/100 Pesos(Php300,000.00)*;

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 34) as an alternative mode and posted the project in the BAC Bulletin Board for the period February 11 to 16, 2026;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, three (3) suppliers were provided with quotation forms namely **A.V.P. CATERING SERVICES, ELJOE'S CATERING SERVICES, BICOL FOOD DELIGHTS CATERING SERVICES**, and two (2) bidders submitted the quotation with results as follows;



- b) To recommend for approval by VP for Admin. & Finance the foregoing findings.




